5. Applicants shall indicate the preferential place of working in the application. However, the VTU reserves the right to post the selected candidates as per the requirement.

7. Age Limit for any contractual basis appointments:

- a. The applicant shall have attained minimum age of 23 years and shall not have exceeded the maximum age specified below as on the last date prescribed for receipt of applications.
 - i. Candidates belonging to SC, ST, and Category-1, Ex-service men and physically and visually disabled/differently abled categories: 55 years
 - ii. Candidates belonging to other Backward classes (OBC) - 2A, 2B, 3A and 3B: 53 years
 - iii. Candidates belonging to General Category : 50 years.
- b. Retired Professors/Associate Professors from IITs, NITs, IIITs, Universities, Government institutions, Autonomous institutions, and AICTE-approved institutions, with very good academic record, may be considered up to 65 years of age, subject to medical fitness. Persons exited from Research & Development, and IT Organization and are inclined towards academics may be considered, with an approval of the selection Committee.
- c. Persons exited from Research & Development, and IT Organizations and are inclined towards academics may also be considered, with an approval of the selection Committee, subject to medical fitness

8. Period of contractual basis appointment:

- a. The appointment shall be purely on contractual basis for a period of eleven months within an academic year from the date of appointment or until a regularly selected candidate assumes charge of the post, whichever is earlier.
- b. The appointment may be extended with periodic renewals, if required, for a further period, not exceeding eleven months at a time, based on the University requirements, available workload and individual appointee performance. Their appointments automatically expire at the end of the specified period. The University may terminate the appointment at any time in accordance with the terms and conditions of appointment.

9. Statutory Reservations:

The statutory reservation policy for recruitment shall be as per the State Government norms.

10. Honorarium/Fixed Pay:

As per University norms.

11. Rights of the University

The University reserves the right:

- (i) To withdraw/cancel/suspend the advertisement either partly or fully at any time without assigning any reason. The decision of the University shall be final, and no appeal shall be entertained.
- (ii) To fill or not to fill up some or all the posts advertised for any reasons whatsoever.
- (iii) To increase/decrease the number of posts at the time of interview/selection and make appointments accordingly.
- (iv) To alter/insert any corrections/additions in the advertisement on the website, if required, before the last date prescribed for submission of applications.
- (v) To cancel any communication made to a candidate in case of any error in the process of selection that is detected at any stage even after the issuance of appointment letter.

12. GENERAL INFORMATION AND INSTRUCTIONS

1. Application shall be submitted in the prescribed format as available on VTU Website only (www.vtu.ac.in). Application in any other format will not be considered.
2. The applicant shall fill the complete application and enclose all required documents as applicable. The incomplete applications shall be rejected and no further communications in this regard is made.
3. Applications received after the prescribed last date will be rejected. The University is not responsible for the transit delay.
4. The selected candidates shall work at appointed place as per the requirement of the University. However, University reserves the right to transfer or depute the selected candidates to other Centers during any period of appointment accordingly to VTU need basis.
5. The selected candidates shall be intimated to join the duty as per VTU academic calendar or as per the requirement of the University. The decision of the University shall be the final.
6. The candidate shall be held responsible for furnishing any false information in the application form and shall be liable for action deem fit including rejection of application.
7. No recommendations shall be made to the University. Influencing in any form for seeking posting, shall disqualify the candidature.
8. The appointed candidates are governed by the Rules and Regulations of the University.
9. No TA/ DA shall be paid either for attending the interview or for joining the post.
